TO BUILD HABITAT HOMES, WE UTILIZE OVER 3,200 ANNUAL VOLUNTEERS AND LEVERAGE DONATIONS OF MONEY AND MATERIALS. OFFERING A HAND UP, OUR PARTNER FAMILIES INVEST 350 HOURS OF SWEAT EQUITY WORK ON OUR CONSTRUCTION SITES AS PART OF THE PROGRAM'S REQUIREMENTS. PARTNER FAMILIES ALSO CONTRIBUTE ESCROW PAYMENTS TO COVER CLOSING COSTS AND ATTEND HOMEBUYER EDUCATION WORKSHOPS THAT PREPARE THEM TO BE INFORMED, RESPONSIBLE HOMEOWNERS. FAMILIES THEN PURCHASE THEIR HOUSE WITH A ZERO-INTEREST MORTGAGE. THE ORGANIZATION SOLD 10 HOMES IN FY 2015 AND HAS SOLD 186 HOMES SINCE 1985.

HABITAT'S CRITICAL HOME REPAIR PROGRAM MIRRORS OUR HOMEOWNERSHIP PROGRAM. WE PARTNER WITH LOW-INCOME FAMILIES WHO OWN THEIR HOME BUT CANNOT AFFORD THE MAINTENANCE NECESSARY TO PRESERVE THE HOME. OUR HOME REPAIR WORK ADDRESSES: CRITICAL ISSUES TO STABILIZE HOMES, WEATHERIZATION WORK TO INCREASE ENERGY EFFICIENCY AND REDUCE UTILITY BILLS, AND ADAPTIVE IMPROVEMENTS TO HELP ELDERLY AND SPECIAL-NEEDS HOMEOWNERS LIVE MORE SAFELY AND SELF-SUFFICIENTLY IN THEIR HOMES. THE HOMEOWNER CONTRIBUTES SWEAT EQUITY WORK AND PAYS A NO-INTEREST LOAN FOR THE COST OF PROJECT MATERIALS. THE ORGANIZATION REPAIRED 88 HOMES IN FY 2015 AND COMPLETED REPAIRS ON 274 SINCE 2010.

THE RESTORE PROGRAM ACCEPTS DONATIONS OF NEW AND GENTLY-USED FURNITURE, APPLIANCES, BUILDING SUPPLIES AND HOME GOODS, AND RESELLS THEM TO THE PUBLIC AT REDUCED COSTS. PROFIT FROM THE RESTORE IS RETURNED TO HABITAT PHILADELPHIA TO FUND HOMEBUILDING AND HOME REPAIR PROJECTS. THE RESTORE BENEFITS SHOPPERS AS A LOW-COST SOURCE OF HOME GOODS; IT PROVIDES DONORS WITH AN EASY WAY TO DISPOSE OF UNWANTED ITEMS AND MATERIALS THAT MIGHT OTHERWISE BE THROWN AWAY; AND IT HELPS THE ENVIRONMENT BY KEEPING GOOD-QUALITY, USABLE ITEMS OUT OF THE LANDFILL.
