OFFERING A HAND UP, FUTURE HOMEOWNERS INVEST 350 HOURS OF SWEAT EQUITY ON HABITAT'S CONSTRUCTION SITES, COMPLETE 14 HOMEOWNERSHIP EDUCATION WORKSHOPS, AS WELL AS CONTRIBUTE ESCROW PAYMENTS TO COVER CLOSING COSTS.
